- 5) The Management is responsible for all risks involved in case of Fire Accident.
- Three (03) Years only from the date of issue of this NOC to the management of M/s St. Augustien EM School, located at Sattenapalli Road, Amaravathi (V & M), shall submit Affidavit/Self Declaration/Certification with regard to working condition of prescribed format and submit/upload the Photographs of the Mock Drills conducted in the premises.
